SECTION 3.10 MLS ONLY PARTICIPANT AND SUBSCRIBER FEES

The Designated Realtor/Participant will be invoiced each month for the number of Iowa licensees hanging under the Participant's firm. An audit of Iowa licensees will be performed by the association staff quarterly.

SECTION 3.10 NOTIFICATION OF NEW AGENTS

All Designated REALTORS shall notify the Board of any additions to their licensed sales staff within 7 days of such changes. All changes must be in writing and signed by the designated REALTOR. Failure to make notification within the designated period will result in a \$25 fine. 7/8/75
