**Fees:**

Monthly MLS Fees are determined by the Board of Directors on an annual basis. For 2022, the fees are \$40.00 for each Iowa licensed agent. Offices are invoiced on a monthly basis for the number of Iowa Licensees in the brokerage firm that have chosen to subscribe including the Broker. A \$25 late fee will be assessed for all dues that are 30 days past due.

**Changes:**

For any changes in membership, including transferring to a different brokerage, notification must be made to the office immediately. All changes must be submitted before the 25<sup>th</sup> day of the month in order for any billing changes to be made in the next month.

**Board Operations Manual Section 3.10: MLS SUBSCRIBER REINSTATEMENT FEE:**
