Broker/ Owner must notify SWIAR in writing/ email within 7 days of all member transfers. Notice must be received by the 25th of the month to allow for processing time to update monthly invoices.

An administrative reinstatement fee of \$350.00 will be assessed for a MLS Subscriber who drops & rejoins within a 12-month calendar year.

There is a \$25 late fee for invoices not paid within 30 days.
